## Update on the Independent Review

In 2012, we commissioned an Independent Review to improve the way in which we operate and to best serve the interests of our members'. The review was led by Sir David Normington and in January 2014 a final report was published with 36 recommendations, which were subsequently adopted. So far, we have delivered 26 of the 36 recommendations outlined in the Independent Review. 12 of the 26 we have completed work on are dependent on the Home Office making regulatory changes and we continue to work with them closely to have the Regulations in place as soon as possible early next year. Work continues on the remaining 10.

## Black Lives Matter Blog

Protesters lay down in the streets at Heathrow, Birmingham and Nottingham under the banner Black Lives Matter UK last month. There were accusations of 'ongoing racist violence by the police' and a 'war on black people'. BLM UK co-founder Natalie Jeffers said 'in Britain someone dies every 6 days in police custody' and 'black people are over-represented in these cases'.
