Smart Delay Plus - Don't Forget



SMART DELAY PLUS

This benefit entitles you to airport lounge access in the event that your registered flight is delayed or a cash sum of £25 if there is no lounge available. For cover to apply you must register each and every flight via the registrations platform. You are unable to claim for both benefits. It only takes a couple of minutes to register. You will need to use the PIN code to access the page. Alternatively scan the QR code below to register. We recommend you register your flight as soon as you book your trip.

IMPORTANT - DON'T FORGET THE FOLLOWING FACTS THAT WE HAVE IDENTIFIED YOU MAY NOT KNOW !

Extended Age

- Cover is now extended to your 80th Birthday (worldwide travel only up until age 75 then European travel only from 75 - 79 along with a [GHIC card](#)).

Extended Cruise Cover

- Inclusion of Cruise extension to provide specific cover including missed departure, skipped port, cabin confinement & loss or damage to cruise attire.

GP 24

- The GP24 service provides you with unlimited 24/7 access to a practising UK-based GP from wherever you are in the world. Consultations are available 24/7 by phone or by video consultation Includes cohabitating family. Experienced GPs are able to provide diagnosis, advice, reassurance or a second opinion and should the GP feel you would benefit from prescription medication they can arrange and electronically authorise private prescription medication, where the medication will be delivered to you at any UK based address the next working day or the prescription emailed direct to a nominated pharmacy. The cost of the drugs are chargeable at wholesale rates which will be told to you before they are issued. To book a GP consultation 24/7 please call: 0345 222 3736

There have been a number of key changes to your policy last year and we cannot stress the importance of taking the time to read your policy booklets to familiarise yourselves with your level of cover.

If you are due to travel on a cruise you can still contact Philip Williams at least 14 days prior to your holiday if your cruise line requests confirmation of your level of cover (other than the travel policy). If you email enquiries@philipwilliams.co.uk you will need to give them the following information:

- Names of Passengers
- DOB of Passengers
- Home Address
- Name of Cruise Company
- Holiday Reference Number
- Dates of Cruise

Philip Williams will then issue you with a headed letter addressed to you at your home address to accompany your holiday travel policy.
