INTRODUCTION

This report provides a summary of responses to the PFEW routine arming survey received from respondents in Devon and Cornwall.

The PFEW routine arming survey was open between 31st July and 1st September 2017. The survey asked respondents about their experiences and attitudes in the following areas:

- Satisfaction with their current access to armed support
- Views on routine arming
- Views on other protective measures and equipment
- The number of times respondents had felt their life had been threatened at work in the last two years

Where appropriate, details of average responses for the police service as a whole are also presented, differences between the national and local responses have not been tested statistically and therefore any differences reported are for guidance only and must be treated with caution.

RESPONSE RATE AND RESPONDENTS

1349 responses were received from respondents in Devon and Cornwall. This reflects a response rate of approximately 47%, based on Home Office figures from 2017. This compares to a national response rate of 27% of federated rank members.

The findings presented in this report have a margin of error of 3%. This margin of error has been calculated using the number of responses received from officers in Devon and Cornwall compared to the number of officers in the force as a whole. A margin of error of 5% or less is generally considered to be within the normal bounds of academic rigor. If this threshold has not been met, the results from this report must be interpreted more cautiously.

78% of responses from Devon and Cornwall were received from male officers and 22% of responses were from female officers. 74% of respondents were Constables, 20% were Sergeants and 6% were Inspectors or Chief Inspectors.

55% of respondents said that they were in a frontline role.

SATISFACTION WITH CURRENT ARMED SUPPORT

Of those respondents who had a view, 34% within Devon and Cornwall said that they were either very or fairy satisfied that armed support would be readily available should they require it. In comparison, 67% were either not very or not at all satisfied that armed support would be available.

Nationally, 43% of respondents were either very or fairly satisfied that armed support would be readily available should they require it.

VIEWS ON ROUTINE ARMING

29% of respondents within Devon and Cornwall said that they were in favour of routine arming, insofar as they felt all officers should receive appropriate training and be armed at all times when on duty. This compares to 34% of respondents across England and Wales as a whole.

51% of respondents within Devon and Cornwall said that they would be prepared to be routinely armed whilst on duty. Nationally, this proportion was 55%. 11% of respondents

within Devon and Cornwall, said that they would not carry a firearm whilst on duty under any circumstances, compared to 11% of respondents in England and Wales as a whole.

VIEWS ON OTHER PROTECTIVE MEASURES AND EQUIPMENT

6% of respondents in Devon and Cornwall (for whom it is applicable to their role), said that they currently had access to double crewing at all times whilst on duty; 55%, said that they wanted access to double crewing at all times whilst on duty.

The proportion of respondents in Devon and Cornwall who said that they have access to double crewing at all times on duty is lower than the national figure, where 11% of respondents have access to double crewing.

38% of respondents in Devon and Cornwall (for whom it is applicable to their role), had access to Taser at all times whilst on duty; in comparison 79% said that they wanted to have access to Taser at all times whilst on duty.

The proportion of respondents in Devon and Cornwall who have access to Taser at all times whilst on duty is higher than the proportion of respondents in England and Wales who had access to Taser at all time, which was 22%.

9% of respondents in Devon and Cornwall (for whom it is applicable to their role), currently had access to Body Worn Video at all times whilst on duty; 68% wanted access to Body Worn Video at all times.

The proportion of respondents in Devon and Cornwall who have access to Body Worn Video at all times whilst on duty is lower than in England and Wales as a whole; nationally 55% of respondents reported having access to Body Worn Video at all times whilst on duty.

THREATS TO LIFE

51% of respondents in Devon and Cornwall said that they had felt that their life was in serious danger at least once in the last two years as a result of a threat by a member the public whilst on duty. This is lower than the 54% of respondents within England and Wales as a whole who felt that their life had been in serious danger in the last two years.

A more detailed breakdown of the number of times respondents in Devon and Cornwall felt that their life had been in serious danger in the last two years is provided below.
