Endorsements

On Duty Assault Firearm/Stabbing/Dog Attack

If an Insured Person sustains Accidental Bodily Injury in the course of duty during the Operative Time shown in the Schedule caused by the discharge of either firearms crossbows or shotguns or caused by assault involving stabbing inflicted by a knife, scissors, screwdriver or wood chisel or similar sharp instrument or as a result of an attack by a dog and as a consequence of the injuries the Insured Person is unable to continue pre-assault duties for a period of at least 3 consecutive days immediately after the attack, We will pay the amount shown in the Schedule following Assault if due to the injuries sustained the Insured person was immediately absent for 3 full consecutive days as they were unable to undertake any duties as a direct consequence.
